

This book provides an in-depth view into the intricacies and challenges of complex tort litigation. It is also a classic David and Goliath story, but this time Goliath wins. It does drag somewhat at times.

Not much to say about the audio. It is very clean and clear and well-produced, but also just as dull and monotonous as any other audio book. As for the book itself, it is one of the best legal, narrative-style nonfictions out there. If you want a better idea of how the legal system actually works in terms of civil procedure (particularly in mass tort cases), this is the book to get. My Civil Procedure professor in law school actually recommended that we read the book at some point during our first semester. Additionally, the book details a very interesting, engaging, heart-wrenching story, and it illustrates certain moral dilemmas sometimes faced by plaintiffs' attorneys. On a separate note, the movie is also fantastic. John Travolta and Robert Duvall are so perfect in their respective roles. Definitely check the movie out too.
