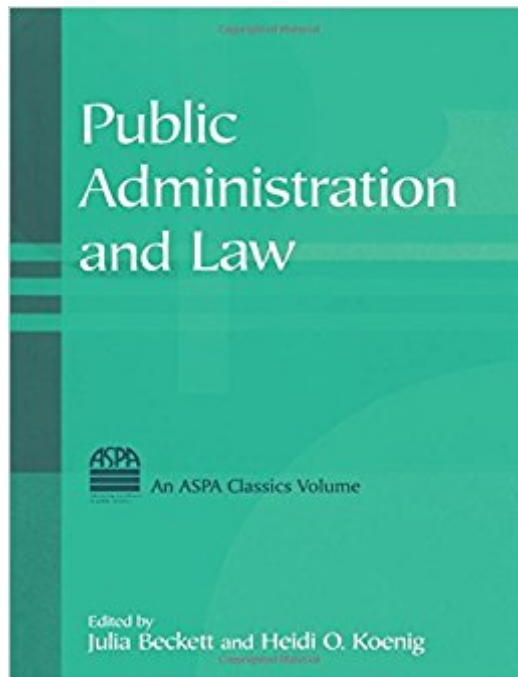

Public Administration and Law has been edited for use as a supplement for an undergraduate or MPA level course on administrative law. The book concludes with two invaluable resources - a bibliography of 65 years of PAR articles concerning public law, plus a bibliography of law-related articles appearing in other journals published by ASPA.
